Partner Reports

ISDA - Trevor Laureys - mentioned that there are 4 ISDA staff openings and internship. 2021 CWI and CREP reports are finished. Tillage transect is happening now. Cover Crop Premium discount program ended the 15th. \$5 back on premium. Trevor spoke about discussing our resolution concerning term limits with the board. They would like to work to take action in the coming months. John Kruse asked about changing some of the transect routes. Trevor said that they can move them, to contact him or Sam Strobel.

Purdue Extension - Walt Sell - Henry Quesada is the new Ag and Natural Resources Program Leader with Purdue. He has PHD in forestry. They have had a meeting for the Kankakee RCPP. Diverse Corn Belt is a program that is a 5 year multidisciplinary program focused on diversity in the landscape.

IDEM - Joe gave report for Angie Brown. Nonpoint Source 319 solicitation comes out April 1. New Rule 5 rules have been causing issues. The state board will try to get an IDEM representative to speak to address Rule 5 in the near future.

CCSI - Lisa Holsher - Deadline to register for cover crop training is next week. That is to get out new midwest cover crop guide book. Training dates are April 5th, 19th, and 26th. Optional in-person day April 12th at Beck Ag Center at Purdue ACRE farm. National Wildlife Foundation has survey that is available to partners to help show impact of events and figure out what is working/what is not. CCSI is considering a Clean Water Indiana ask for some of the returned funds. Grants committee will meet in April to discuss. Lisa asked for side by side comparison pictures to show effect of conservation practices working well. Lisa asked for us to ponder grain donation challenge.

SICIM 2021 annual written report - Joe will try to make sure they are connected with NACD RPG. Amy will share some of their videos on our website that highlight the work being done throughout the state. IASWCD will provide certificate of insurance for their annual meeting.

Joe presented SICIM legislative ask. Conversation ensued. Joe will communicate the boards initial thoughts back to SICIM before June meeting.

Public must be allowed to attend in person. All rules are posted on our website. Senate Bill 85 created drainage task force. We are recommending Jeff Healy from Hendricks county for this spot.

Mark Kingma made the motion to recommend Jeff Healy for the Drainage Taskforce, and John Kruse seconded, motion passed.

NACD Fly-In. All federal offices have been contacted. Most are scheduled. Ideas were pitched to engage legislators and continue the contact. Sarah brought up putting together profiles for legislators to narrow in on issues that we can improve alignment with conservation and their thoughts/feelings.
