
ABOUT

2022 President's Perspective



Bobby Hettmansperger, Wabash County, IASWCD Board President, 2021-2022

2022 was a year of navigating through our "new normal."

In the first quarter of the year, the Indiana Legislature convened for a short session. IASWCD met with partners and legislators, telling our conservation story and advocating for continued state Clean Water Indiana (CWI) funding. Various natural resource concerns were on the docket, including watershed commissions and drainage. In the fall, a new drainage taskforce was created and included a seat for an SWCD board supervisor.

The IASWCD Executive Director served on the Wetlands Taskforce this year, completing a report that, among other recommendations, discusses the need for additional conservation investment.

In late spring, IASWCD, in partnership with the State of Indiana Cooperative Invasives
Management (SICIM), began a campaign to raise Clean Water Indiana funding in the next general assembly by \$8.6 million per year.
The campaign, Clean Water Indiana: Next Level Conservation for Working Lands, will need districts to assist during the legislative session in early 2023 to continue this campaign initiative of \$9.57 million, which includes the previous \$970,000.

IASWCD continues to be a resource and support for Indiana's 92 Soil & Water Conservation Districts. We are proud to have delivered on our mission amidst many challenges. Thank you to our SWCD members for entrusting us to advocate on your behalf.



2022Fiscal SummaryExpenses*






