In 2023, we collectively secured **funding from the state legislature** for the Clean Water Indiana (CWI) program. This significant increase of funding will be provided in both 2023 and 2024 to support conservation efforts throughout the state. We look forward to hearing more

about how these funds are making a difference in your communities and the overall health of Indiana's waterways and soil health efforts.

The IASWCD board met in June to develop a **Strategic Plan** that will guide the organization over the next three years. This plan (see page 5) will provide a roadmap for IASWCD to be more intentional in our services to Districts and their needs. One immediate result from this plan was hiring a **Legislative Affairs Manager** that will provide a consistent presence at the statehouse and guide districts in connecting with legislators. We also hired a **Grants and Finance Manager** to help us responsibly manage \$1 M in grants annually for programs that benefit Indiana Soil & Water Conservation Districts, like the Conservation Cropping Systems Initiative (CCSI), the Urban Soil Program (USH) and the new Resilient Indiana Program.

We continued our work with our partners at ISDA to help develop the **Board Certification Program** (BCP) and supported IDEA in their development of their groundbreaking employee training program. These achievements would not be possible without the deep commitment of our state association board representing your interest



and the Board's Staff, State of Indiana Invasives Cooperative Management (SICIM) partner, and, of course, our 92 member Districts. Thank you for all you do each day for conservation.





IASWCD is the financial administrator for conservation initiatives benefiting districts and natural resources across the state, including CCSI and USH. A new program titled Resilient Indiana (RITA), backed by NRCS and Clean Water Indiana (CWI) funding, will gradually expand its operations over the next five years, delivering technical support to districts.



IASWCD oversees the financing of the Pathway to Water Quality exhibit, an annual showcase at the Indiana State Fairgrounds focusing on watershed education. This exhibit receives funding from the Indiana Conservation Partners (ICP) and is staffed by volunteers from across the state.

SUPERVISOR OF THE YEAR MIKE NORMAN

Mike Norman has been an exemplary supervisor at Fulton County SWCD since 1992. He actively advocates for conservation, participates in securing funding at the State House, attends various meetings, and participates in educational programs. We appreciate his dedication to conservation practices and the district.

FRIEND OF CONSERVATION HELP THE HELLBENDER

The Help the Hellbender Project, led by Dr. Rod Williams and Nick Burgmeier (Purdue University) aims to conserve the declining hellbender salamander population in the Sinking Blue River Watershed. Through education, captive rearing, and habitat restoration, they've released 500 juveniles since 2017 and secured \$2.7 million for conservation projects.

DISTRICT SHOWCASE AWARD

MONTGOMERY COUNTY - BUILDING CAPACITY

In response to community demands, Montgomery County SWCD expanded its services, requiring a new staff position. A Clean Water Indiana grant funded a Program Coordinator, facilitating enhanced outreach, organized events like 4th-grade field days, and increased conservation practices adoption. Partnerships bolstered their efforts, leading to permanent county funding for the position.

NEWTON COUNTY - STUDENT INTERNS

Various Newton County organizations, like the SWCD, Jasper Newton Foundation, IDNR, and TNC partnered to create a Student Conservation Internship Program. Aimed at high school students, it offers paid work experience in natural resources, fostering career exploration and workforce development while addressing local conservation needs.

The Kosciusko County Urban Healthy Soils Working Group targets small urban, rural farmers, and home gardeners, providing educational resources and technical assistance. Community collaboration strengthens the district's conservation efforts, fostering growth and adoption.

STATEWIDE PROGRAMS

The Indiana Association of Soil and Water Conservation Districts (IASWCD) administers three programs which provide practical, technical, and supportive assistance to enhance soil and water conservation efforts statewide. Funding for these programs is provided by NRCS and the Clean Water Indiana program.



Resilient Indiana: Technical Assistance (RITA) for SWCDs is an initiative by the Indiana Association of Soil and Water Conservation Districts, supported by USDA NRCS and Clean Water Indiana. Its aim is to enhance SWCDs' capacity in promoting climate change mitigation on agricultural lands.



The Conservation Cropping Systems Initiative (CCSI), in collaboration with the Indiana Conservation Partnership, offers science-based education and technical assistance on soil health farming practices to farmers and industry influencers.



The mission of the Urban Soil Health Program (USH) is to improve soil health in urban and small-scale farms and gardens across Indiana through education and advocacy. Collaborating with conservation partners, USH establishes local Soil Health Working Groups, tailoring education and assistance to small-scale vegetable growers.
