


# Indiana Private Lands Access Program (IPLA) 2024 Update

#### What is IPLA?

- Surveys show that the number one barrier facing hunters today is access to land to hunt.
  - Public lands are overcrowded.
  - More and more private land is being leased for exclusive hunting rights.
  - People are moving to urban areas and looking for more convenient places to hunt near where they live.
- The Indiana Private Lands Access Program (IPLA) was started in 2017 as part of the Grasslands for Gamebirds and Songbirds initiative.





#### Who is a fit for IPLA?

- Landowners must be in the VPA focal region to be eligible for funds – for now.
- Most of our best landowners are people we already have a relationship with.
- Absentee landowners are usually a good fit.
- The more hunts you are willing to offer, the more money you can make as a landowner.
- Must have reasonable amounts the game we are pursuing.
- We do not target land that is already being hunted. We don't want to displace people who are currently hunting a property.






## What does IPLA offer landowners?

- Money
  - The more hunts you offer, the more money you can make!
- Habitat improvement money
  - Unfortunately, the habitat money cannot be used on existing CRP, WRE, etc. Hopefully, this changes with the next VPA
- Priority access to our habitat teams
  - DNR teams that will come do your habitat work for you!









## **IPLA History**

- IPLA started with fall 2017 hunting season (gamebirds only)
- First turkey hunts in spring
  2020
- VPA funding introduced in 2020 (\$537,000 for access, \$750,000 total)
- First waterfowl hunt enrolled in fall 2020
- First deer hunts enrolled in fall 2021
- First small game hunts enrolled in 2022

■ Gamebirds ■ Deer ■ Turkey ■ Small Game ■ Waterfowl






#### Gamebirds – Where it all started...








#### **Turkey Hunting**

It was one of the best turkey hunts I have been on. Watched 5 Tom's beat up my decoys for over an hour then tried mating with my hen for another 30 min - David










#### **Deer Hunting**




#### Waterfowl and Small Game Hunting














### Hunter Survey (n=104)






How likely are you to participate in an IPLA reserved hunt on this property if it was offered again?




How likely are you to participate in an IPLA hunt on a different property?






## Landowner Survey
